4.00% INITIAL RATE

The initial rate of 4.00%/4.0775% APR is based on a 30-year mortgage with a 20% down payment. At the initial rate, there would be 360 payments of \$477.41 on a 30-year, \$100,000 loan. Payments do not include taxes and insurance, which will affect your obligation.

After the initial 7 year period, the interest rate may adjust every 36 months, *but never more than one percentage point per adjustment period and no more than a total of three points during the life of the loan.* Over the life of the loan, the note rate can never exceed 7.00% or fall below 4.00%.

If, after seven years, the note rate adjusts to 5.00%, monthly payments on a 30-year, \$100,000 loan would be \$525.31. If, after 10 years, the note rate adjusts to 6.00%, monthly payments would be \$570.27. If, after 13 years, the note rate adjusts to 7.00%, monthly payments would be \$611.45 – and your rate and payment will NEVER increase further for the life of your loan!
